Subject: Advisory to Ministries, Departments and Other Organizations (MDOs) for implementation of Mission Karmayogi Guidelines - Reg.

In continuation of this Department OM no. T-28/95/2023-iGOT dated 01.11.2023 (enclosed), the following advisory is issued to Ministries, Departments and Other Organizations:

2. Onboarding and Preparation of Capacity Building Plan (CBP) of attached/subordinate offices:

All MDOs are requested to ensure that:

- 2.1 Capacity Building Unit (CBU) is formed in the attached/subordinate organizations to coordinate capacity building activities therein. The CBU formed at the Ministry/Department level may render such support to the CBU of attached/subordinate organization, wherever feasible.
- 2.2 SPV-Karmayogi Bharat may be requested to onboard the attached/subordinate organizations onto iGOT-Karmayogi portal, if not already done.
- 2.3 All officials of the attached/subordinate organizations may be instructed to register on the iGOT-Karmayogi portal and start consuming courses available on the platform.
- 2.4 The Capacity Building Plan (CBP) may be prepared for the attached/subordinate organizations, in consultation with Capacity Building Commission (CBC), wherever feasible. Necessary financial support may be provided to the attached/subordinate organizations for the same, if required.

3. Preparation of Mandatory Immersion Programme (Know Your Ministry)

- 3.1 The MDOs may ensure that the Know Your Ministry (KYM) module encapsulates the History, evolution, context and purpose of setting up the Ministry.
- 3.2 The KYM module may further be curated to include those contents of use for newly inducted officials/officers to enable them to appreciate the functioning of the Ministry including Unique functions performed, processes prescribed to handle those functions, details of competency building products already available on iGOT specific to the MDO, details of Office Memorandums (OMs)/Rules/Instructions relevant to the MDO (subject matter-wise), compilation of important decisions taken etc.

4. All MDOs are requested to report on the compliance of the aforementioned points in its quarterly report to be sent to DoPT (vide para 4 of this Department OM dated 01.11.2023 enclosed).

Subject: Implementation of Mission Karmayogi Guidelines - reg.

The National Programme for Civil Services Capacity Building – Mission Karmayogi has been launched by Government of India to develop a citizen-centric and future-ready civil service through democratized and competency-led capacity building, which encompasses in its scope a mandate that unifies the efforts of structured, formal and service-based training through Civil Service Training Institutions (CSTIs) with on-demand digital training through iGOT-Karmayogi platform.

- 2. Mission Karmayogi Guidelines have been issued by this Department vide OM no. T-16017/6/2023-TFA dated 28.07.2023 (enclosed) to bring clarity to the roles and responsibilities of various stakeholders in the training and capacity building landscape, including that of institutions established under Mission Karmayogi.
- 3. In furtherance to the above, the following may be ensured: -
- 3.1 Ministries/Departments/Other Organizations (MDOs)

All MDOs are requested to ensure that:

- 3.1.1 The Capacity Building Plan (CBP) has been prepared and is under implementation.
- 3.1.2 100% of employees are on-boarded onto iGOT-Karmayogi platform before December 31, 2023.
- 3.1.3 Every employee onboarded completes at least 6 hours of training on iGOT-Karmayogi platform from the quick win courses identified in the respective CBP within the next 45 days.
- 3.1.4 Available courses on iGOT-Karmayogi portal are consumed by employees based on the training calendar proposed in the CBP.
- 3.1.5 Know Your Ministry module is prepared, in consultation with Capacity Building Commission (CBC) and is included in the induction training of all officers posted to the MDOs.
- 3.1.6 All CSTIs under its administrative control are on-boarded onto National Standards for Civil Service Training Institutions (NSCSTI) portal before December 31, 2023 and sign up for accreditation. The same may be insisted upon as a condition for increase in its funding.

- 3.1.7 Course partners/ course developers for domain competencies are identified and development and operationalisation of domain courses are prioritized.
- 3.1.8 Quarterly progress report on implementation of CBP (proforma enclosed) is sent to DoPT till the time CBP-linked dashboard is enabled by SPV.

3.2 Civil Service Training Institutes

The CSTIs under the administrative control of the Ministries are requested to ensure that:

- 3.2.1 Competency Building Products (CoBPs) are developed in response to demand raised by MDOs in its respective Capacity Building Plans.
- 3.2.2 Periodic Training Need Analysis is conducted to identify the relevant content and for curation of the CoBPs. The content so created must be in conformity with the relevant guidelines and policy framework issued by CBC from time to time. Content Quality Framework issued by SPV-Karmayogi Bharat also be factored in while digitizing content for onboarding on iGOT.
- 3.2.3 Existing course content is digitized into e-content by developing and utilizing in-house capabilities/ digital infrastructure or through engagement of academic institutions/ private content development agencies/ subject matter experts in consultation with CBC and SPV.
- 4. All Ministries are requested to send the quarterly report, commencing from the quarter ending December 31, 2023.
- 5. This issues with the approval of the Competent Authority.

Sub: Karmayogi Guidelines, 2023.

The undersigned is directed to say that this Department is the nodal agency of Government of India for matters related to training of Civil Servants.

- 2. The Civil Services play a central role in governance and its delivery of public services. To equip the civil services with the right attitudes, skills, knowledge and competencies aligned to the demands and expectations of a rapidly growing economy and its aspirational citizens, Government of India launched the National Programme for Civil Services Capacity Building (NPCSCB) Mission Karmayogi. The Mission Karmayogi aims at developing a citizen-centric and future-ready civil service and through democratized and competency-led capacity building, which encompasses in its scope a mandate that unifies the efforts of structured, formal and service-based training through Civil Service Training Institutions (CSTIs) with the on-demand digital training through iGOT- Karmayogi platform.
- 3. To deliver on the vision of capacity building of Civil Servants, two key institutions viz. Capacity Building Commission (CBC) and the Special Purpose Vehicle (SPV) Karmayogi Bharat were designated. The CBC has become fully functional since June, 2021, while the SPV Karmayogi Bharat has become operational since August, 2022 and has been managing and maintaining the iGOT platform. Further, the e-HRMS has been revamped and integrated with iGOT platform.
- 4. It is envisaged that the institutional training interventions in complementarity with online capacity building interventions on iGOT would facilitate the overall objective of shift from rule-based system to a role-based Human Resource Management in Government. The National Training approach, therefore, has to harmoniously blend and realign the role of various CSTIs so as to fully complement the efforts of other pillars of Mission Karmayogi.

- 5. Therefore, these "Karmayogi Guidelines" (as per the **Annexure**) are being issued to bring more clarity to the roles and responsibilities of various stakeholders in the training and capacity building landscape, including that of the institutions established under the Mission Karmayogi.
- 6. All the Ministries / Departments, including CSTIs and other organizations functioning under their administrative control, are requested to comply with these guidelines.
- 7. In so far as the State Governments are concerned, it is recommended that they may formulate comprehensive guidelines for training and capacity building of their employees, in consonance with these guidelines, to enable achievement of citizen-centricity and effective public service delivery.
